- 5 Rehabilitation of the airport including tiling of pavements, feeder roads and the baggage belts. The latter particularly at terminal 1D (hitherto Domestic Terminal) were a frequent nuisance to passengers whose bags would get stuck in the conveyors.
- 6 Changed the airport look by initiating the "greening beautification project" by planting trees, grass and flowers transforming the hitherto dry, brown looking landscape to the now fresh green new look an aspect noted by non-other than the H.E the President of the Republic of Kenya.
- 7 Upgraded the power system from 11 KVA to 66 KVA ensuring adequacy and stability of power at the Airport.
- 8 Created oneness and harmony at the airport with all stakeholders hitherto unknown, and championed preparation of a customer service handbook for entire KAA.
